

## The following are the terms and conditions (“the rules”) of the Hospice Isle of Man ‘TT Prize Draw 2026’.

The prize draw is a form of gambling and participants are encouraged to gamble sensibly. More information about responsible gambling can be accessed [here](#).

Hospice Isle of Man is also known as Hospice Care which is a registered charity in the Isle of Man with charity number 317. Hospice Care is registered with the [Isle of Man Gambling Supervision Commission](#) and operates this prize draw as a ‘Society Lottery’ under the Isle of Man Gambling, Betting and Lotteries Act 1998. The Isle of Man Courts have exclusive jurisdiction over the Hospice Isle of Man Honda Grom Prize Draw. The promoter of this lottery is Vanessa Smith, Head of Income Generation, Hospice Isle of Man, Strang, Isle of Man, IM4 4RP. The cost of each entry ("ticket") is £15 and players must purchase at least one ticket in advance to be entered into the prize draw. There are 2000 tickets available.

By entering the Hospice Isle of Man Honda TT Prize Draw, you agree to be bound by these rules.

### 1. The prizes include:

- 1<sup>st</sup> Prize: One new Honda MSX125 Grom in Candy Victory Blue (Isle of Man registered, valued at over £3,500 inclusive of VAT);
- 2<sup>nd</sup> Prize: a four-night stay for two in a Premier Glamping Pod at the DHSOB Campsite, Blackberry Lane, during the 2027 Isle of Man TT Race Week (valued at £760);
- 3<sup>rd</sup> Prize: £100 worth of official TT merchandise.
2. All OTR (on the road) costs or additional vehicle specification for the Honda MSX125 Grom chosen by the winner, will be at the winner’s own additional expense.
3. The four-night stay is redeemable for any dates during the 2027 TT Race Week, subject to availability (provisionally set for Saturday 5<sup>th</sup> June – Saturday 12<sup>th</sup> June 2027).
4. To enter the prize draw you must be aged 16 (sixteen) or over.
5. There are no rollovers or prize alternatives.
6. In order to enter the prize draw, you will be required to provide certain personal information including your name and contact information and accept that it is your responsibility to keep us informed of any changes as soon as they arise. You acknowledge that we cannot be held responsible for our inability to contact you should you win if you have not provided us with up to date contact information.

8. At our discretion, we may make tickets available for purchase over the telephone or other venues up until the date of the draw.
9. Tickets available in Hospice Shop outlets may be sold via a virtual system where details for the customer are not collected and the ticket number(s) associated to a purchase are printed onto a till receipt immediately provided to the customer (an “In-Store Ticket”). In these circumstances the onus is on the customer to keep the till receipt and check their number(s) against winning ticket details published by Hospice Isle of Man following the draw taking place.
10. In the event that the prize is won by an In-Store Ticket, the winner will need to contact Hospice Isle of Man and supply the till receipt containing the winning number to Hospice Isle of Man as evidence of the legitimacy of their claim. The prize cannot be claimed without supply of this till receipt evidence. In exceptional circumstances where a till receipt is lost, Hospice Isle of Man may, at its sole discretion, attempt to verify the legitimacy of a claim using available transaction records.
11. In the event that the prize is won by an In-Store Ticket, the winner will have until the 4<sup>th</sup> January 2027 in which to supply their till receipt and claim the prize. In the event of the prize not being

claimed within this time period, Hospice Isle of Man reserves the right to utilise the prize for other purposes at its discretion.

12. Hospice Isle of Man cannot be held responsible for any incorrect or inaccurate prize draw information supplied to an entrant by any third party in connection with this prize draw.
13. We can at any time and without assigning any reason, refuse to accept your entry into the prize draw.
14. All tickets purchased for the prize draw are final and no refunds shall be made at any time.
15. You acknowledge that your purchase of a prize draw ticket does not guarantee that you will win the prize.
16. The winner will be chosen on Wednesday 8<sup>th</sup> July 2026. The winner of this draw will be chosen at random by computer. We reserve the right to amend the draw date accordingly and will post that revised draw date on this website.
17. The draw will take place at Hospice Isle of Man, Strang, Douglas, IM4 4RP. You do not need to be present at the draw to win the prize.
18. All decisions on the winner are final and no further correspondence will be entered into.

By purchasing a ticket in the prize draw, you accept that as a winner, Hospice Isle of Man reserves the right to publicise the winner's image, approximate geographic location and non-identifying information such as your first name or initials; online, on social media or any other appropriate media type.
20. Full payment for each prize draw ticket must be received in the form of cleared funds before your ticket number can be entered into the draw.
21. The winner of the prize draw will be contacted either by telephone, email or letter.
22. The prize can only be delivered to an address in the Isle of Man. Where the prize draw winner resides outside the Isle of Man, it will be the winner's responsibility for covering shipping logistics & costs, import/excise duties, other related taxations and any other associated costs of transportation of the vehicle from the Isle of Man to their place of residence.
