TERMS & CONDITIONS

DEFINED TERMS: In these terms and conditions:

Plan.com Charity Committee ("Charity Committee") is an Isle of Man charitable committee which is registered with the Isle of Man Gambling Supervision Commission.

plan.com Santa's on a Bike tombola means a tombola/raffle/prize draw which is being run by the Charity Committee

Ticket means a ticket for plan.com Santa's on a Bike tombola

Entrant means the holder of a Ticket.
